### Description of product, including key attributes

This is a Qantas Points Home loan secured over real property. The key attributes are:

- > loan amounts from \$150,000
- > loan terms of up to 30 Years
- > variable interest rate
- > owner occupied or investment
- > interest only/principal and interest reducing/combinations
- > minimum deposit 10%
- > repayment frequency can be weekly/fortnightly/monthly
- > interest only options available, with monthly repayments, subject to approval
- > a redraw facility available to redraw advance repayments
- > 100% loan offset account available
- > Qantas rewards points on loan balance
- > must provide a registered first mortgage over real property or other acceptable security

**This product is not suitable for retail clients who:**

- > are seeking a fixed interest rate
- > are not seeking to earn reward points
- > are seeking bridging finance to purchase a property prior to selling their existing property
- > need progressive drawdowns to complete the construction of a home
